RESOLUTION REQUESTING THE CENR OFFICER, CULASI, ANTIQUE TO CAUSE FOR THE SENDING OF SURVEY TEAM TO CONDUCT SURVEY OF THE SPECIFIC DISTANCE/AREA IN RADIUS COVERED BY THE NATIONAL PARK AND WILDLIFE RESERVATION AREA SURROUNDING THE MALUMPATI HEALTH SPRING AND TOURIST RESORT, THIS MUNICIPALITY

WHEREAS, the areas surrounding Malumpati Health Spring and Tourist Resort in this municipality was declared as National Park and Wildlife Reservation Area in accordance with the present program of the National Government on environmental protection and preservation;

WHEREAS, to maintain and to preserve the ecological balance and natural bountiness of greeneries and wildlife species within the area there is a manifest need to determine / pin-point the specific distance in radius of the areas covered by the National Park, so that it is incumbent upon this Body to seek and request for the needed technical assistance of proper authorities and government agency concerned to cause for the sending of Survey team in relation thereof;

NOW, THEREFORE, on motion by Hon. SB Member Gaspar T. Estomata duly seconded by SB Members Emmanuel V. Samulde and Celedonio A. Dionela, this Sanggunian, in regular session, assembled, resolved, as it is hereby resolves, to request As it is hereby requested the CENR Officer, Culasi, Antique, to cause for the sending of Survey Teams to conduct survey of the specific distance in radius covered by the National Park and Wildlife reservation area surrounding the Malumpati Health Spring and Tourist Resort, this municipality.
