**RESOLUTION NO 104-96**

**RESOLUTION BAYAN RESOLUTION ESTABLISHING THE POLICY OF PROTECTING AND PRESERVING THE PHYSICAL AND ENVIRONMENTAL CONDITIONS OF BUGANG RIVER, THIS MUNICIPALITY**

**WHEREAS,** Bugang River is the inland bodies of water in this municipality covering the barangays of Zaldivar, Sto. Rosario and Guia. The main tributary source which comes from the clean and crystal clear water of the renowned Malumpati Health Spring and Tourist Resort;

**WHEREAS,** this Sanggunian, in its desire to maintain the clean and ecological surroundings of Bugang River had enacted the "ANTI-LITTERING" Ordinance, series of 1994, prohibiting the dumping of garbage, wastes, rubbish, rice husks, and other matters in rivers, brooks, creeks, and rivulets situated within the municipality;

**WHEREAS,** to protect and preserve further, the physical and environmental conditions of the Bugang River it has become proper and imperative for this Sanggunian to involve and to encourage the citizenry in the protection and preservation of Bugang River, particularly those who own land adjacent to the river, to plant trees Along within the river bank, and to report accordingly to the proper authorities any illegal logging

activities covering the area of “Malumpati Health Spring and Tourist Resort” and the Bugang River;

**WHEREAS**, this Body is of the belief that in order to attain further with this noble undertakings there is a need to initiate information campaign and people’s participation relative thereof.

**NOW, THEREFORE**, on motion by Hon. GORGONIO D. VARUA, seconded enmasse, this Sanggunian, in regular session assembled, resolved, as it hereby resolves, to establish, as the same is hereby established, the policy of protecting, preserving the physical and environment conditions of Bugang River.

**RESOLVED, FURTHER**, to direct, as he is hereby directed, the Secretary to the Sanggunian, to furnish with copy of this resolution, to all the Barangays in this municipality, for the their information and proper dissemination of the provisions of this resolution.
