RESOLUTION NO. 227- 2003

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPALITY OF PANDAN, ANTIQUE AND STO. ROSARIO MULTI-PURPOSE COOPERATIVE FOR THE IMPLEMENTATION OF COMPONENT DEMONSTRATION COMMUNITY BASED TOURISM PROJECTS UNDER THE TOURISM DEVELOPMENT AND PROMOTION PROGRAM PHASE 2 AND THE TRANSFER OF FUNDS PROVIDED BY THE LGSP FOR THE IMPLEMENTATION OF THE COMPONENT INTERPRETATIVE CENTER PROJECT

WHEREAS, this Municipality has entered into Memorandum of Agreement with the LGSP for the implementation of a demonstration community-based tourism project;

WHEREAS, the Sto. Rosario Multi-Purpose Cooperative based in Barangay Sto. Rosario this municipality, manifests its willingness to actively participate in the implementation of this community-based tourism project that would form a partnership binding upon this Local Government Unit and its component barangays particularly the civil societies for a mutual cooperation towards development of tourism industry in the locality;

WHEREAS, the Interpretative Center is one of the component projects that was anticipated to give ease upon the community members who would be engaged in tour guiding, souvenir shops, socio-cultural experience and other tourism circuit activities for which the LGSP has provided the amount of P60,000.00;

WHEREAS, it would be a meaningful start of cooperation between this Municipality and civil societies towards community-based tourism industry development in this community to let the Sto. Rosario Multi-Purpose Cooperative manage the implementation of the Interpretative Center project.

NOW, THEREFORE, on motion by Hon. SB Member Marissa M. Napat, duly seconded by Hon. SB Members Edesio G. Pechon, Tony R. Chan, & Jesus O. Tamboong, this Sanggunian, in a regular session assembled, resolved, as it hereby resolves, to authorize the Municipal Mayor to enter into a Memorandum of Agreement between the Municipality of Pandan, Antique and Sto. Rosario Multi-Purpose Cooperative for the implementation of component demonstration community-based Tourism Projects under the Tourism Development and Promotion Program Phase 2 and the transfer of funds provided by the LGSP for the implementation of the component Interpretative Center Project.
