RESOLUTION NO 52-2001

RESOLUTION GRANTING PANDAN WATER DISTRICT (PWD) A FIVE-YEAR
CONTRACT TO MANAGE, SUPERVISE AND MAINTAIN THE MALUMPATI
HEALTH SPRING AND TOURISM RESORT (MHSTR) AND AUTHORIZING THE
MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT
(MOA) RELATED THERETO

WHEREAS, the Pandan Water District was previously granted by the Local
Government Unit (LGU) of Pandan of a one year contract to manage, supervise and
maintain the Malumpati Health Spring Tourism Resort (MHSTR) as per approved
Sangguniang Bayan Resolution No. 53-2000 and Resolution No. 77-2000 approving the
Memorandum of Agreement (MOA) between the said two entities;

WHEREAS, after a through evaluation of the one year operation of Malumpati
Health Spring Tourism Resort (MHSTR) by the Pandan Water District, (PWD) the Local
Government Unit (LGU) had found out it to be advantageous particularly to the

Environment protection of the surroundings, improvement and maintenance of structures, prevention of vandalism.

WHEREAS, the Local Government Unit of Pandan, through this august body, hereby recognize and appreciate the performance of the Pandan Water District, and furthermore, is highly confident of a more developed and improved tourist considering the sincerity and capability of the said entity;

NOW, THEREFORE, on motion by Hon. Renato D. Tugon, M.D. duly seconded by SB Members, Celedonio A. Dionela, and Johanna Marie D. Cahilig, this Sanggunian, in a regular session assembled, resolved, as it hereby resolves, to grant, as it is hereby granted, Pandan Water District (PWD) a five-year contract to manage, supervise and maintain the Malumpati Health Spring Tourism Resort (MHSTR) and authorizing the Municipal Mayor to enter into a Memorandum of Agreement (MOA) related thereto.
