RESOLUTION NO 63-2000

RESOLUTION ADOPTING THE APPLICABLE SECTIONS ON LOCAL GOVERNANCE OF PRESIDENTIAL DECREE NO. 705, REVISED FORESTRY CODE OF THE PHILIPPINES, AS AMENDED BY EXECUTIVE ORDER NO. 277.

WHEREAS, there is urgency to conserve the remaining forest resources of the country, for the benefit and welfare of the present and future generations of the Filipinos;

WHEREAS, the implementation of our forestry laws suffers from technical difficulties, due to certain inadequacies in the penal provisions of the Revised Forestry Code of the Philippines;

WHEREAS, an Executive Order No. 277 was issued in order to overcome these difficulties, and likewise to attain an effective conservation and protection program by way of a vigilant enforcement and implementation of our forestry laws, rules and regulations;

WHEREAS, the Local Government Unit (LGU) of Pandan, Antique through this august body, cognizant of advantageous effect of the forestry laws to the environment of the Municipality of Pandan, hereby convey its confidence and firm belief to the wisdom of the said laws;

NOW, THEREFORE, on motion by **Hon. Renato D. Tugon, M.D.**, duly seconded by Hon. SB Members, Ma. Julie M. Venus and Edesio G. Pechon, this Sanggunian, in a regular session assembled, resolved, as it hereby resolves, to adopt, as it is hereby adopted, the applicable Sections on Local Governance of Presidential Decree No. 705, Revised Forestry Code of the Philippines as amended by Executive Order No. 277.
