RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE SALVACION ZALDIVAR PEREZ, GOVERNOR, PROVINCIAL OF ANTIQUE, FOR THE ACQUISITION OF MOTORIZED BANCA WITH FIVE(5) HP ENGINE TO BE USED AS GARBAGE/DEBRIS COLLECTOR AT BUGANG – MALUMPATI RIVER

WHEREAS, it is a fact that Bugang-Malumpati River had given prestige and glory to the Municipality of Pandan having been chosen as the cleanest inland body of water in Region VI, for several times;

WHEREAS, in order to maintain the beauty and cleanliness of the said river, the Local Government unit of Pandan (LGU) believes that the most effective scheme of clearing it from garbage/debris is through the use of a motorized banca;

WHEREAS, considering the deficiency in the local government coffers, the Local Government Unit (LGU) through this august body wish to convey with regret to the Honorable Governor Salvacion Zaldivar Perez, its financial incapacity to purchase the said motorized banca;

NOW, THEREFORE, on motion by Hon. Marissa M. Napat, duly seconded by Hon. Members, Patria F. Candari, Tony R. Chan, Celedonio A. Dionela, and Mildred R. Camero, this Sanggunian, in a regular session assembled, resolved,, as it hereby resolves, to request financial assistance from Hon. Salvacion Zaldivar Perez, Governor, Province of Antique, for the acquisition of motorized banca with five(5) HP engine to used as garbage/debris collector at Bugang-Malumpati River.
